Subject:- Increase in the seats in clinical subjects for medical colleges/institutions of J&K State – update of Online preference forms by desirous NEET PG 2017 eligible candidates.

Public Notice No. 016–BOPEE of 2017 Dated 29-03-2017

Whereas, the Government of India vide communication dated 28-03-2017 have reportedly approved increase in the PG seats for three medical colleges/institutions of the State as under:-

Whereas, the formal communication has not been received by the Board from the concerned medical colleges/institutions, which is mandatory for filling up of the additional seats;

Whereas, in view of likely increase of these seats during the current session, it has been decided to advise the candidates who wish to update their preferences as a consequence of above and subject to notification of the seats to the Board by the medical colleges/institutions, to inform the Board in writing about their desire to update their preferences;

Whereas, this step is being taken in advance to ensure that the admission process is completed in a time bound manner;

Now, therefore, it is hereby notified that:-

1. The PG candidates who have locked their Online Preferences and made the Online payment upto 22nd March, 2017 midnight and desire to update the same in case the above seats are notified to the Board may send a request to the Board on the

“specially created e-mail” along with all biodata and a copy of the latest preference form submitted by them so that in case of increase in the seats, the request of such candidates who wish to update their preferences is examined and considered and further action taken accordingly;

2. Request of such candidates who have not deposited Online fee shall in no case be considered;
3. This is purely for purposes of taking action in anticipation of the actual updation of seats and mere making the request to the Board to update the preferences without actual increase in the number of seats notified by the prescribed authority shall not confer any right on candidates to claim any revision/updation in the preferences. Board will take a decision only after the seats are notified to it by the prescribed authority and take a decision in respect of such candidates only;
4. No request for any updation at a later date shall be entertained by the Board in any case;
5. The candidates desirous of making a request to the Board may do so within a period of four days w.e.f. 29-03-2017 to 02-04-2017 midnight at the following e-mail address:-

6. The list of candidates who make a request in this regard shall be notified by the Board if it is decided by the Board to consider the same depending upon notification of seats by the colleges/institutions to the Board.

It is further notified that while making the request a candidate shall forward the following:-

1. Name
2. Testing ID
3. Date of Birth
4. NEET Rank
5. NEET score
6. State Rank
7. Last preference copy signed.

Note:-

1. This shall not be construed as any change in the Seat Matrix as of now which can be done only after the formal notification is received.
2. No additional fee shall be paid for staking claim/making a request for change in preferences as a consequence of above.

3. The decision of the Board on the subject shall be final which shall be taken after the seats are notified formally by the colleges/institutions in a time bound manner so that the admission process is not delayed beyond the prescribed time frame as laid down by the MCI/Hon'ble Supreme Court.

The Board reserves its right to fill up the additional seats in the manner as laid down in the Information Brochure, if it is found that due to delay in notification of the additional seats, it will not be possible for the Board to fill up the same in a time bound manner, and if any delay will result in non adherence of the schedule notified by MCI.
